● **Hunt test:** Judges and grounds approved, as well as captain of guns.

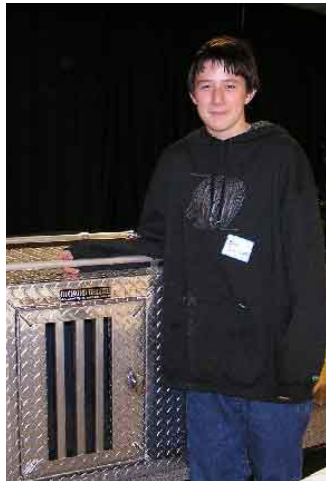
Meeting adjourned at 7:57pm.
